

PROMOTION TERMS AND CONDITIONS

THESE ARE THE OFFICIAL PROMOTION TERMS AND CONDITIONS. PARTICIPATION IN THE PROMOTION CONSTITUTES ACCEPTANCE OF THESE PROMOTION TERMS AND CONDITIONS (THE “PROMOTION TERMS”).

Definitions:

Participating Facilities: Cascades Casino Penticton

Promotion: Wheel of Cash is a promotion in which both Encore member slot players and non-Encore member slot players who are Qualified Entrants will receive entry ballots with no purchase necessary in order to enter a Draw at any given Draw Time in order to win cash Draw Prizes. See the “How to Enter the Promotion” Section below for more details.

Promotion Period: August 6, 2026 at 7:00am PT to September 16, 2026 at 7:59pm PT.

Draw Days: August 12, 19, 26, September 2, 9, 16 2026 at 4:00pm PT and 8:00pm PT.

Draw Prize(s): A total of Twelve (12) Draw Prizes will be available to be won for a maximum combined total of Twelve thousand Canadian dollars (\$12,000 CAN) in cash prizes. One (1) Draw Prize will be awarded at each Draw Time on each Draw Day.

The maximum total prize value that may be won by a Drawn Entrant at a single Draw Time is one thousand Canadian dollars (CAN \$1000), awarded in cash.

Once a Drawn Entrant has been selected, the Drawn Entrant will be allowed to spin the Prize Wheel in order to determine their prize value as detailed in the How to Win a Draw Prize section below.

Gateway:	Gateway Casinos & Entertainment Limited
Draw:	A draw for a Draw Prize at each Draw Time.
Drawn Entrant:	Qualified Entrant whose Slot Machine number has been drawn, as a result of a manual Hot Seat Draw.
Gaming Day:	The 24-hour period from 7:00am PT on one day to 6:59am PT the following day during the Promotion Period.
Qualified Entrant:	An individual who is 19 years of age or older, but does not include: • Current or former employees of BCLC and Gateway (or any of its affiliates) and their family and household members who reside at the same residence • Individuals who have been banned from any casino and/or community gaming centre (whether by Gateway, BCLC or otherwise) and participants in BCLC's Voluntary Self-Exclusion (VSE) Program • Residents of New York, Rhode Island, Florida or Texas.
Winner's Authorization Form:	Such representations, indemnities and releases as Gateway may require in its sole discretion from a Drawn Entrant in consideration of and in order to induce Gateway to deliver a Draw Prize to the Drawn Entrant.

How to Enter the Promotion:

1. Encore membership is not required.
2. Qualified Entrants may receive one (1) entry ballot per every hand paid jackpot during the Promotion Period.
3. **No Purchase Necessary Entry Method:** All Qualified Entrants may attend Guest Services on Friday, Saturday and/or Sunday during the promotion period to receive one (1) entry ballot per day at the Participating Facility for the Draw taking place at the next Draw Time (no purchase/play necessary).
4. **Additional No Purchase Necessary Entry Method:** Qualified Entrants may receive an entry ballot in the Promotion without purchase by writing a short Two Hundred & Fifty (250) word essay stating the Qualified Entrant's favorite Okanagan Summer Activity. Upon completion of such essay, the Qualified Entrant must bring the completed essay to the Guest Services Desk no later than 2 hours prior to the Draw Time on the next available Draw Date during the Promotion Period. If the essay is complete, as determined by a Gateway in its sole discretion, a Guest Services Supervisor, Manager or Participating Facility designate of Gateway will award three (3) entry ballots to the Qualified Entrant for the applicable Draw. This method of earning entry ballots can only be used once per Qualified Entrant per Promotion Period.



5. Qualified Entrants must return the completed ballot to Guest Services to be entered into the Draw Barrel prior to each Draw Time in order to qualify.
6. The Draw Barrel will be closed 5 minutes prior to each Draw Time.
7. Qualified Entrants must be present at the Draw Time to win.

How to Win a Draw Prize:

1. Odds of winning a Draw Prize are based on the total number of entry ballots in the draw barrel at draw time.
2. Under surveillance at the Participating Facility, two (2) IGCO registered employees will conduct each Draw at the Draw Barrel to select one Drawn Entrant. The Drawn Entrant must be present to win. Drawn Entrants will have two (2) minutes to present themselves at the Draw area to have the opportunity to claim their prize.
3. If a Drawn Entrant is not present, another draw will be conducted until a winner is present. This process will continue until a winner is declared.
4. The Drawn Entrant will be offered to spin a Prize Wheel containing sixteen (16) value spots to determine the total prize awarded.
5. The Drawn Entrant will be given one (1) opportunity to spin the prize wheel and will be eligible to win the cash prize indicated by the segment on which the wheel comes to rest. To be considered valid, each spin must complete no fewer than three (3) full revolutions of the prize wheel. Any spin that completes fewer than three (3) full revolutions.
6. shall be deemed invalid and must be re-spun.
7. Each prize segment on the wheel is separated by a metal divider. If the wheel comes to rest and the clacker (pointer) is positioned directly on a metal divider, such that it is not clearly resting within a single prize segment, the spin shall be deemed invalid and must be re-spun. For greater certainty, a spin shall be considered valid if the clacker is resting within a single prize segment, even if the clacker is touching one of the metal dividers that forms the boundary of that segment, provided all other requirements set out herein have been satisfied.
8. Draw Barrel will be emptied after each 8:00pm PT Draw during the Promotion Period.
9. A Drawn Entrant will be required to present valid government issued photo identification, prior to proceeding further with the Draw Procedure.
10. A Drawn Entrant must complete a Winner's Authorization Form in the presence of two (2) IGCO registered gaming employees, before the Draw Prize can be released.
11. The winning entry will be checked against the Voluntary Self-Excluded and Barred lists. If the winner's name appears on any of these lists, the entry will be disqualified and another entry will be drawn.
12. Gateway's Surveillance Department will record each Draw and will hold the footage in its entirety for thirty (30) days.
13. Each Qualified Entrant may win more than one (1) Draw Prize per Promotion.

General Conditions:

1. No purchase is necessary to participate in the Promotion.
2. Encore Rewards membership is not required.

3. All winners must correctly answer the mathematical skill-testing question outlined below before any prize is awarded:

9. Gateway makes no representations or warranties whatsoever, either expressed or implied, oral or written, in respect to any prize.
10. Gateway is not responsible for any typographical errors in the administration of the Promotion and/or in any promotion related materials.
11. All prizes must be accepted as awarded and are non-transferable. The refusal by a Qualified Entrant to accept any prize releases and forever discharges Gateway from all obligations to that Qualified Entrant in connection with the Promotion, including delivery of any prize.
